International Handicraft & Handloom Fair-10 is scheduled to be held at Hotel Mayfair, Bhubaneswar from 24th to 26th, 2010 as Reverse Buyers & Sellers Meet (RBSM) under the scheme Market Access Initiative of Ministry of Commerce, Govt. of India.

Any person / Company / Institution/ Organization which is manufacturing/ dealing in handicraft and handloom products of Orissa or intend to do such business.

Terms and Conditions:

1. For the purpose of participating in IHHF-10 the participants shall have to apply in the prescribed application form to Member Secretary, SIDAC, Bhubaneswar.
2. SIDAC reserves the right to accept or reject any application for participation in IHHF-10.
3. There is no participation cost. However, each selected participant shall have to deposit Rs.500/- in cash/ bank draft in favour of Member Secretary, SIDAC, payable at Bhubaneswar for entry in the Fair Directory.
4. Built in stall / booth with display & light arrangement shall be allotted to each participants by SIDAC. Size of the stall/ booth shall be decided by SIDAC.
5. The participants shall have to submit the list of items to be displayed on or before 10th February, 2010 to SIDAC to facilitate erection of stall/ booth with display arrangement.
6. SIDAC reserves the right to decide which products/ exhibits which may or may not be displayed by the participants.
7. The names & address of the participants with stamp size color photographs shall be deposited at SIDAC on or before 10th February, 2010 for issue of entry pass.
8. The participants should report at exhibition site by 3.00 p.m. on 23/02/ 2010 with the exhibits and submit the list of items to Officer-in-charge of the event. Proper display of the items should be made sufficiently before inauguration of the event. Each product to be displayed should be tagged with its specification & price. Participant may have product CD/brochures for information of the buyer.
9. Participants are not allowed to use poster, wall paper, paint, drilling of nails & screws for display. The participants shall remain in charge of exhibits. SIDAC will not be responsible for any damage/loss of the exhibit. Insurance coverage against such loss shall be made by the participant.
10. The participant should maintain the cleanliness of the stall as well as the venue.
11. A visitor's book shall be maintained by each participant.
12. Any dealing with the buyers shall be reported to Exhibition Office every day immediately after closure of the business hour.
13. Any damage that will be made by the participant to the event/assets of the venue/contractors material will be recovered from the participant.
14. The packing materials shall be removed from the display area & kept outside the exhibition hall.
15. No TA/ DA/ TC shall be paid for participation.
16. Accommodation for stay & working lunch for the participant shall be provided by SIDAC as per provision.

17. Maximum two persons will be allowed for each stall/booth. At no point of time the stalls/ booth should remain un-attended.
18. The stall/ booth should be vacated by the participant within 2 hours after closure of the event at his/her own cost.
19. The participant can not transfer, dispose or part with or otherwise sublet whole or part of the stall/ booth allotted.
20. In case of breach of rule & regulations on the part of the participant, they shall be driven out of the Exhibition hall and will be black listed to participate in future events.
21. The participant should maintain discipline and refrain from such activities which will hamper proper holding of the event and tarnish the image of SIDAC as well as the image of the State.
